Location: Kenwood Country Club. Meeting Called to Order: 10:35 am. Number of Members Present: 32



Motion: to approve the Slate of Candidates for the 2023-2024 PGITI Lead Team proposed by Carole Wilkinson (Chair), Seconded: Alex Pooley, approved by Kirsten Scott and then by member majority.

Carole mentioned that we still need more people to organize events and that we lost six members from our LT last year. She noted that while we had filled some roles, we still had vacancies: co-secretary (to ensure we always have someone at meetings to take notes) and two individuals for family events (to organize the fall and winter events).

Review of the Year Events: Elizabeth Thornton. She covered the events conducted year-to-date and those planned for next year. She thanked Rose Lambert for her help with the Learning Kitchen and Gemstone events. She also highlighted that we provide grants to interest groups that want to organize events on behalf of, and open to, all PGITI members. She mentioned that the Indian Subcontinent interest group had planned two Diwali parties in the past, and the Latin American group is arranging the upcoming Latin party. Elizabeth encouraged other groups to organize more events in the future.

Interest Groups Activities - Nicole Schulten mentioned the 9 activity groups and 6 language groups. Two new groups have been created "Majong" and "Volunteering". We thanked Faizah Byer for leading the "Gourmet" and "Culture and Cuisine" groups and Marisol for the Book Club 2. Both were presented with a small gift. Caron, British group leader, shared that the group hosts monthly activities centered on British culture and historical themes. She highlighted some of the great events we've had and invited everyone to participate in future activities.

Newcomers Welcome: Caron shared that we have 25 new people from 14 different countries.

Membership: Shelly Helser shared her personal experience of returning to the U.S. after her international assignment. She discussed how this experience changed her perspective and how it helped her connect with like-minded people in PGITI. She also offered some advice for newcomers to the U.S. and suggested a way to learn about American culture by watching the movie "NFL Trading."

Closure: Carole thanked everyone for participating and closed the meeting at 11.28. **Speaker:** Sam Settlemeyer from Civic Garden Center gave us a presentation on pollination.
